## 2. AIM

This Legal Notice aims to regulate the use and protection of User data on the Website with URL **www.cione.es** and the different available Areas, Services and Products on the Website (hereinafter, the "Services").

Users accessing and browsing **www.cione.es** and/or using the Services offered on the Website accept each clause of this version of the Terms of Use published by **CIONE GROUP** when accessing **www.cione.es**. Therefore, all Users must understand the importance of reading the Terms of Use on this Website.

LIKewise, ACCESSING AND USING CERTAIN SERVICES, WHETHER OWN OR THIRD PARTY, WHICH ARE AVAILABLE TO USERS ON **WWW.CIONE.ES** AND WHICH ARE MANAGED BY THE **CIONE GROUP** MAY BE SUBJECT TO CERTAIN GENERAL TERMS AND CONDITIONS OF CONTRACT OR ADDITIONAL REGULATIONS ON USE OF THE WEBSITE. ACCORDING TO EACH CASE, THE ABOVE TERMS AND REGULATIONS MAY REPLACE, AMEND AND/OR PROVIDE ADDITIONAL INFORMATION. THEREFORE, THE USER MUST READ AND ACCEPT THESE TERMS AND CONDITIONS BEFORE ACCESSING THE WEBSITE AND/OR USING THESE SERVICES AND CONTENT.

## 3. WEBSITE CONTENT

The Website of the **CIONE GROUP** provides Users with an online catalogue of products and services that are directly and/or indirectly related to the optical and audiology sectors.

## 4. OWNERSHIP OF THE WEBSITE CONTENT

All elements hosted on the Website: text, images, trademarks, audio and video files, logos, software files, combinations of colours, as well as the structure, selection, layout and presentation of contents are the property of the **CIONE GROUP** or of third parties, and they are protected by Spanish and international Industrial and Intellectual Property laws. Likewise, without prejudice to the above, the Website content is regarded as a software application and, as such, the applicable Spanish and EU regulations must be complied with.

By accessing the Website, the User is not granted any rights to use its content, whether existing or future, for its own personal use, i.e., beyond what is strictly required for the correct use of the Website.

## 5. TERMS OF USE AND ACCEPTANCE

By accessing and using this Website, the User acknowledges their status as such and fully accepts these Terms of Use, along with any specific conditions established for specific provided on the Website. Moreover, the User undertakes to use the Website and its Services in compliance

with the Law, this Legal Notice, the specific terms of certain Services, and any other applicable notices, regulations and guidelines, as well as with morality, generally accepted ethical standards and public order.

The Website may be freely visited by Users, excluding functions hosted in restricted areas, or which require Users to sign up, which would require them to complete the corresponding "User registration form". The form must be completed according to the regulations of the Service or any other applicable Terms and Conditions.

- Encourage, provoke or support unlawful, offensive, defamatory, slanderous, violent behaviour or, in general, any actions that go against the law, ethical principles, public order or commonly accepted moral standards;
- Encourage, provoke or support actions, attitude and opinions related to discrimination on the grounds of age, race, religion, gender or condition;

- Cause the malfunction of the Website or its Services due to its design characteristics (such as the format, extension, etc.);
  - Contain HTML tags different to those that are expressly authorised by the **CIONE GROUP**.

The user undertakes to using the content on the Website properly, including but not limited to, the texts, photographs, graphics, images, icons, technology, software, links and other audio-visual and sound content, as well as the graphical design and source code, in compliance with the law and these Terms of Use, the specific conditions of certain Services and other notices, regulations, terms of use and instructions appearing on the Website, as well as according to moral standards and public order or widely accepted good customs, and public order, and, in particular, undertakes to refrain from:

## 6. PRIVACY AND DATA PROCESSING

When certain contents or services needed to be accessed to provide personal data, Users will guarantee the truthfulness, accuracy, authenticity and validity of such data. The **CIONE GROUP** shall process the data with the corresponding automated processing systems, according to their nature or purpose, under the terms included in the section on the Privacy Policy.

With regards to anonymous browsing, the **CIONE GROUP** shall only gather and store the following information from Users browsing its Website:

- The domain name of the Internet service provider.
- The date and time of access to the **CIONE GROUP's** Website
- The URL of the website from which the link leading to the **CIONE GROUP Website's was generated.**
- The number of daily Users of each section.

The information obtained will be totally anonymous and cannot be linked to a specific User or be used to identify Users.

With regards to **browsing cookies**, the **CIONE GROUP** does not use Cookies or other applications to obtain the personal data from the User without his/her consent.

With regard to personal data, Users are informed that, in compliance with Organic Law 3/2018 on the Protection of Personal Data and Guarantees of Digital Rights (LOPDGDD), on the Law on Information Society Services and E-commerce (LSSI-CE) and the General Data Protection Regulation (GDPR), the **CIONE GROUP** is the data processor of a file that stores the data gathered from its customers who browse the **CIONE GROUP's** website or which are managed by the Group; in relation to enquiries, requests or for the arrangement of services/purchase of products; or any transaction or operation carried out.

The personal data is provided on a voluntary basis, but it is needed to maintain the commercial relationship.

User's data will be managed to process and fulfil the terms and conditions of the commercial relationship, and to send advertising contents about certain activities, products, posts, services, offers, special promotions and documents of a different nature of the **CIONE GROUP** and other entities of the optical, fashion, leisure, jewellery and cosmetics sector, via different channels (including email or SMS). In the case of the latter, the information sent by the **CIONE GROUP** will only refer to services or products according to your profile and which best suit your characteristics and/or needs.

Users accept to have their data disclosed for the sole purposes indicated in the above paragraph to subsidiaries or participated entities of the **CIONE GROUP**, in particular "**COOPERATIVA INDUSTRIAL DE ÓPTICA SOC. COOP. CIONE**" (**CIONE**) and "**FUNDACIÓN CIONE RUTA DE LA LUZ**" (detailed and up-to-date information about the Group's entities can be found at [www.cione.es](http://www.cione.es)).

Finally, we inform you that your data may be transferred to Financial Institutions with the purpose of managing payments and collections.

If you do not wish to receive information about the activities, latest features, publications and/or any other information about the **CIONE GROUP** or of subsidiaries and participated entities of the **CIONE GROUP**, the User must send an email to [datos@cione.es](mailto:datos@cione.es) (Partner Assistance Service) or a letter by post to: Parque Empresarial Pinar de las Rozas, calle José Echegaray 7 – 28232 Las Rozas (Madrid), including your request.

To cancel or revoke the data subject's express consent to the processing of their personal data, the **CIONE GROUP** may terminate the agreement to provide the service if this is required to ensure optimum delivery of its services.

## 7. INDUSTRIAL AND INTELLECTUAL PROPERTY

The User acknowledges and agrees that all content displayed on the Website, including but not limited to designs, texts, images, logos, icons, buttons, software, trade names, trademarks or any other symbols designed for industrial and/or commercial use, are subject to Intellectual Property rights, and that all trademarks, trade names and distinctive signs, along with all industrial and intellectual property rights related to the content and any other elements hosted on the Website, are the sole property of the **CIONE GROUP** and/or of third parties, who have the exclusive rights to use them to market their products and services.

**Publishing photographs, videos, articles, blogs, messages, web pages, storing files or public disclosure of any other content on the CIONE GROUP's Website will entail recognition in favour of the CIONE GROUP of an indefinite and free license according to the comprehensive scope established in the applicable laws, which is also non-exclusive and with a global coverage, to use, copy, sub-license, adapt, transmit, execute or disseminate to the public any content, for free and commercially, of any of the rights mentioned above, whether fully or partially.**

The content, texts, photographs, images, computer software, source code and, in general, any intellectual creation hosted on the Website, as well as the Website as a whole, as a multimedia work of art, are protected by the current intellectual property laws with the corresponding copyrights. The **CIONE GROUP** is the holder of the elements included in the graphical design of the Website, such as menus, browsing buttons, HTML code, texts, images, textures, graphics or any other content on the Website. In any case, the CIONE GROUP has the corresponding authorisation to use such elements.

The Website's content may not be fully or partially reproduced, nor recorded with any type of information recovery system or with any other means or methods, unless the express authorisation is given in writing by the Entity.

Likewise, it is strictly prohibited to eliminate, avoid or tamper with the "copyright", as well as with the technical protection devices or any other information mechanisms that could contain the content. Users of the Website undertake to respect the above rights and to prevent any type of action that could be detrimental to such rights. To this end, the **CIONE GROUP** reserves the right to exercise any legal actions to protect its legitimate intellectual and industrial property rights.

## **8. OBLIGATIONS AND RESPONSIBILITIES OF THE WEBSITE'S USERS**

The User undertakes to:

- Reproducing or copying, distributing, allowing public access through any public communication method, transforming or editing content, unless this is authorised by the holder of the corresponding rights and this is legally permitted;

If a password is required to access some of the Website's contents and/or services, Users will be required to ensure that it is kept secret at all times. As a consequence, Users will be responsible for not sharing the password with anyone, undertaking to not disclose or transfer it to third parties whether temporarily or permanently, nor to allow access to these services and/or contents to unauthorised persons.

Likewise Users will be required to inform the Group about any event that could be associated with the unauthorised use of their password, such as, but not limited to, its theft, loss or unauthorised use, so the password can be immediately cancelled. As a consequence, before the

above notification is made, the **CIONE GROUP** shall not be held liable for any responsibility derived from improper use of the password. Therefore, the Website's Users will be responsible for any illegal use of the content and/or services by unauthorised third parties. In the event of negligent or intentional failure to fulfil any of the obligations established in these General Terms of Use, the User will be responsible for any damages and losses that may result for the **CIONE GROUP**.

## 9. LIMITATION OF LIABILITY OF THE CIONE GROUP

Uninterrupted access, correct visualization, downloading or usability of the elements and information on the website cannot be guaranteed, as they may be prevented, restricted or disrupted due to factors beyond its control. The CIONE GROUP shall not be held liable for the decisions adopted as a consequence of access to the content or information offered.

The service shall be interrupted or the relationship with the User terminated immediately if it is detected that the Website or any other services available on the Website are not being used according to these General terms of Use. The CIONE GROUP shall not be held liable for any damages, losses, claims or expenses derived from using the Website.

It will only be responsible for eliminating as soon as possible any content that could generate such problems, provided that it is notified about this.

In particular, the **CIONE GROUP** shall not be held liable for any form of harm that may derive from the following, among others:

1. Disruptions, interruptions, malfunction, omissions, telephone line faults, delays, blockages or disconnections in the electronic system's operation, due to deficiencies, overloads and errors in telecommunication lines and networks, or any other factor beyond the **CIONE GROUP's control**.
2. Unauthorised interference using malicious software of any type and through any communication medium, including computer viruses or similar threats.
3. Inadequate or improper use of the Website.
4. Security or browsing errors caused by issues in the browser or due to using old versions of the browser. The Website's administrator reserves the right to fully or partially remove any content or information hosted on the Website.

The **CIONE GROUP** shall not be held liable for damages of any nature derived from improper use of the free services by the Website's Users. Likewise, the **CIONE GROUP** shall not be held liable for any consequences arising from the content and information received in the contact forms, which will only be used to answer enquiries and doubts. Moreover, if any damages are caused due to the illegal or incorrect use of such services, the User may be asked to compensate for such damages.

Users shall not hold the **CIONE GROUP** liable for any damages derived from third-party claims, actions or lawsuits as a result of their access to or use of the Website. Likewise, Users will be required to compensate the **CIONE GROUP** of any damages caused by the use of robots, spiders, crawlers or similar tools used to gather or extract data or any other action that increases the Website's load over normal levels.

## 10. INSERTING HYPERLINKS

- Must provide a direct link to the **CIONE GROUP's** website without allowing external websites from reproducing the contents of the **CIONE GROUP's** Website as part of its website or within its frames, or create a browser on any of the Website's pages. The CIONE GROUP may ask Users to eliminate any link to the Website at any time, which must be immediately deleted by Users.

The **CIONE GROUP** cannot control the information, content, products or services on other websites with links to its Website.

In addition, Users and any person who wishes to include a hyperlink to their website or portal to the Website must meet the following conditions:

- The hyperlink will only direct to the Website's "Home Page" but may not reproduce its contents.
- A frame will not be created with the Website's links.
- No false, inaccurate or incorrect statements will be made about the links to the Website and the Forums Service.
- No content on the Website will infer that the **CIONE GROUP** has authorised a hyperlink to be used or that it accepts to provide the Services offered or posted on the Website in connection to the hyperlink.
- Except for the signs included in the hyperlink, the page with which the hyperlink is linked will not contain any distinctive sign owned by the **CIONE GROUP**, in compliance with the current Laws, unless the CIONE GROUP has expressly authorised this.

## 11. NOTIFICATIONS

## 12. DURATION, MODIFICATION AND INTERRUPTION OF THE SERVICES

The **CIONE GROUP** reserves the right to interrupt the Services when deemed appropriate, in particular, for Users who violate the provisions set forth in these terms of use. Likewise, the **CIONE GROUP** may improve its Services and, in the benefit of Users, modify the content of the Website at any time and without prior notice, or any aspect of the Website or its conditions in terms of functioning, techniques and usage. Likewise, with a view to improving the Website and establishing optimum quality levels, a priority and core aim of the **CIONE GROUP**, Users may suggest any changes they deem to be useful by contacting the **CIONE GROUP's** supervisors or managers.

## 13. STATEMENTS AND WARRANTY

## 15. DISPUTE RESOLUTION. APPLICABLE LAW AND JURISPRUDENCE

These General Terms of Use and any form of use of the Website will be governed by the Spanish legislation. The parties shall submit to the Courts and Tribunals of Majadahonda (Madrid) to resolve any dispute.

Should any provision of these General Terms of Use be deemed unenforceable or void under the applicable legislation or as a result of a judicial or administrative ruling, such unenforceability or nullity shall not render these General Terms of Use as a whole unenforceable or void. In these cases, the **CIONE GROUP** shall modify or replace this stipulation with another one that is valid and enforceable and that, to the extent possible, achieves the aim and intention reflected in the original stipulation.
